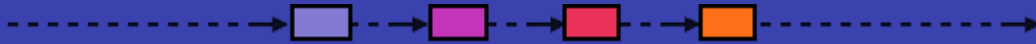

EC meeting attendance



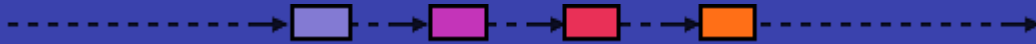
- EC members who miss two meetings in a row lose their voting privileges until they have attended two in a row.

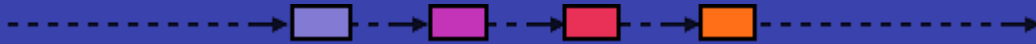
- Jim Gough replaces Ben Evans as LJC's primary rep. Ben becomes a secondary rep.

Java SE8 launch



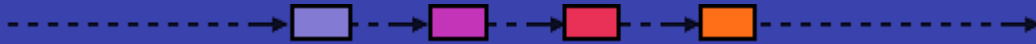
- Java SE 8 was approved on March 11.
- The release will be launched with a webcast on March 25.
 - Live keynote and 35 supporting technical screencasts.
 - See <http://www.oracle.com/technetwork/java/javase/overview/index.html>.
 - The launch will be preceded by a Java 8 NightHacking tour of 28 JUGs led by Java Evangelist Steven Chin.
 - Adopt-a-JSR and Adopt-OpenJDK material is included.
- JUG leaders are encouraged to request visiting speakers or to run their own events using presentation materials to be provided by Oracle.
- The JCP will host an Adopt-a-JSR online meeting on Thursday, 20 March.

Proposed election schedule for 2014



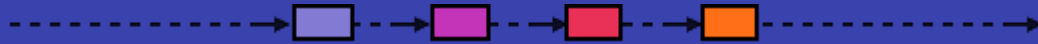
- Follow-up from January f2f discussion...

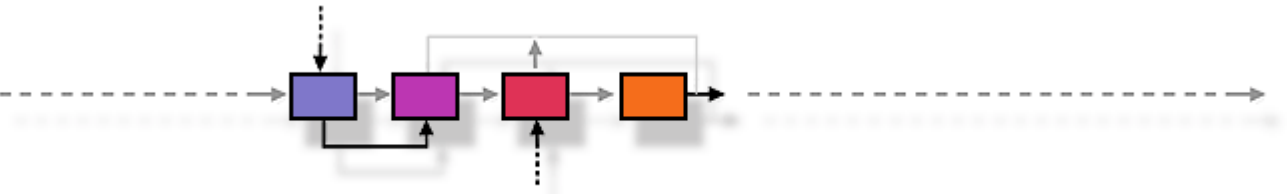
