



#### **JCP.next: Ballot-stuffing**

- Employees of member companies may join the JCP as individuals (with their employer's consent.)
- This enables ballot-stuffing (employer runs for office, and encourages employees to register as individuals so they can vote in the election.)
- Should employees of a member company be prohibited from voting in elections?
  - Always, or only if their employer is running?
- What privileges should be reserved for those who sign the JSPA?
  - We want to be more transparent, and to enable broad participation, but need to reserve some privileges for those who become full members.



#### **JCP.next: Member roles**

- 1) Passive observer: reads public forums.
- 2) Occasional participant: comments in public forums.
- 3) Active member: votes in elections, joins Expert Groups.
- 4) Spec Lead: incurs significant IP-related obligations.


