#### Loss and restatement of voting privileges

- From the Standing Rules:
  - "Missing two meetings in a row (whether teleconference or face-to-face meetings) results in the loss of voting privileges in all JSR ballots and EC votes that have not yet started. An EC member who has lost voting privileges cannot make or second a motion. *Privileges* are regained after full attendance at two consecutive meetings."
  - (Emphasis added for discussion purposes.)



#### Issues

- During a recent discussion several members argued that privileges should be restored at the beginning of the second consecutive meeting that a previously nonvoting member attends.
  - If so, we will need to modify the Standing Rules.
- The Rules currently require *full attendance* at two consecutive meetings.
  - To what extent, and if so how, should we police this?
  - Do we want to change it?
  - AT&T did not fully attend the February meeting.
  - Their partial attendance at that meeting therefore ought not to be counted for reinstatement purposes.



## Implementation in jcp.org business logic

- JSR ballots usually start (logically) at 00:01 am on Tuesdays, even if the ballot is not opened until later in the day.
- EC meetings are usually held on Tuesdays.
- (If Monday is a holiday, "Tuesday" becomes "Wednesday.")
- If a member loses voting privileges at/after a meeting that starts on a Tuesday they will be permitted to vote in a ballot that starts on that day.
- If a member regains voting privileges at/after a meeting that starts on a Tuesday they will not be permitted to vote in a ballot that starts on that day.
- Loss/reinstatement of privileges therefore happens on the day after the EC meeting finishes. Ballots that started on the same day as the meeting are unaffected.


