PMO General Topics

The PMO presented its usual set of statistics and updates. EC members were reminded of their duty to vote and participate in the meetings of the EC. Also EC members were asked to review the minutes from the previous meetings to ensure we have correctly recorded the attendance. The PMO also discussed with the EC members the initial results of an internal look at how to get the ECs more involved in events of the community and JavaOne.

OOPSLA

EC members were provided with a full listing of events at OOPSLA and a list of JSRs that may be represented at the conference. EC members were encouraged to participate in the conference on behalf of the JCP and to contact the PMO if they needed any help.

JSR Spring Cleaning

The PMO presented results of an effort that began earlier this year to encourage lagging JSRs to either move through the process or withdraw themselves from it. A list of JSRs that were considered lagging by the PMO, and therefore contacted, was presented and a brief update was given on each one. EC members were encouraged to continue keeping an eye on the lagging JSRs that had not withdrawn, to ensure they moved completed their next stage.

JSR 215 Update

The PMO presented the current status of the JSR and the results of the Community Review. They were also reminded of the ballot period at the end of the month. The PMO presented a roll-out plan for JCP 2.6 also, and EC members were encouraged to provide feedback to the PMO on that plan. The next hurdle for the JSR 215 work was identified to be the Spec Lead Guide changes.

Uber Ad Hoc Update

The proposals on the table were discussed again, and EC members were encouraged to have their legal teams take a look at the proposals as well. The proposals were tabled for further discussion at the face-to-face meeting at the end of September.
