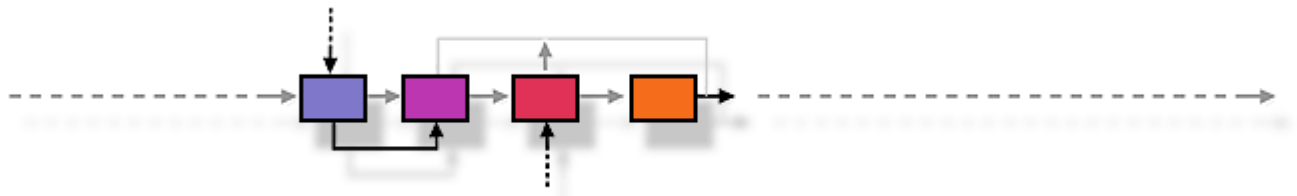

JSR 364 implementation plan



- Update JCP.org with necessary changes for JCP v2.10.
- Implement EchoSign for electronic signing of agreements.
- Create a form for joining with links to the Membership Classes and Workflow Chart documents.
- Ensure existing renewal form clarifies requests for changes in employment status.
- Migrate JSRs and Memberships to new versions.
- Give Individual Members 60 days notice starting in March 2016 according to renewal dates.
- Membership drive and education March - September 2016 leading up to EC Elections.

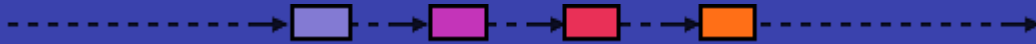

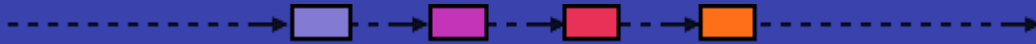

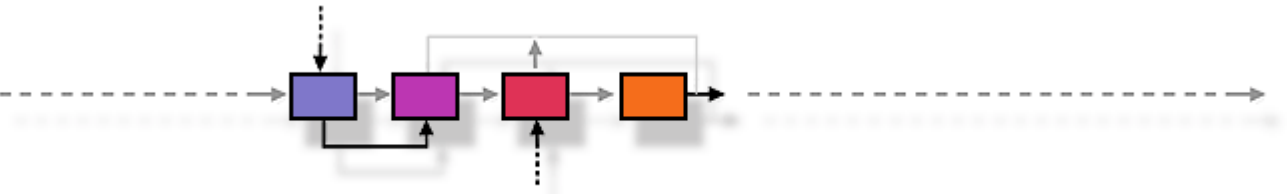
